Req: Minutes of the SLBC Sub-Committee meeting on MSME held on 11.03.2025.

The SLBC Sub-Committee meeting on MSME was held on 11.03.2025 to review the performance of the member banks under MSME as on 31.12.2024. The meeting was chaired by Shri Rajesh Pandey, Principal Secretary, Dept. of MSME & T, Govt. of West Bengal and participated by Shri Udayakumar Swaroop, Joint Secretary, MSME & T, Govt. of West Bengal, Shri Manas Dhar, Director & Special Secretary, Institutional Finance, Finance Department, Govt. of West Bengal, Shri Sakshi Gopal Saha, SPMU of WBBCCS, Govt. of West Bengal, and representatives of RBI, NABARD & major member banks.

Shri Balbir Singh, General Manager & Convenor, SLBC West Bengal, heartily welcomed all the participants in the meeting, delivered opening remarks and requested Shri Rajesh Pandey, Principal Secretary, Dept. of MSME & T, Govt. of West Bengal, to preside over the meeting. The key issues discussed along with the action points emerged in the meeting are enumerated below:

1. MSME ACP 2024-25 vis-à-vis achievement as on 31.12.2024:

Member banks have disbursed Rs. 148906.45 Cr. in MSME, thus achieving 97.00 % against ACP target of Rs. 1,53,509.18 crore as on 31.12.2024. Disbursement in MSME has increased by Rs.27,815.63 crores in absolute terms as on 31.12.2024 from Rs.121090.82 Cr. as on 31.12.2023 thus registering a growth of 22.97 % on Y-O-Y basis. Shri Rajesh Pandey, Principal Secretary, Dept. of MSME & T, Govt. of West Bengal, congratulated all the member banks and urged upon to surplus the annual target.



2. West Bengal Bhabishyat Credit Card Scheme (WBBCCS) as on 31-12-2024:

As on 31.12.2024, total 1,53,277 no. of applications have been sponsored to banks, out of them, 32,388 no. of proposals have been sanctioned amounting Rs.686.75 Crore and 20474 no. of accounts have been disbursed amounting Rs.425.88 Crore. Member banks are again requested to instruct their branches for disposal of pending loan proposals under the scheme in a time-bound manner.

In view of the huge pendency of WBBCCS applications in various bank branches, the Principal Secretary advised the house to organize a special campaign starting from 17-03-2025 to 21.03.2025 for immediate disposal of both the pending for credit decision and pending for disbursement of already sanctioned cases. Shri Pandey also advised SLBC to monitor closely for making the campaign a success.
