Re: Minutes of the SLBC Sub-Committee meeting on Digital Payment held on 30.07.2026:

A meeting of SLBC Sub-Committee on Digital Payment was held on 30.07.2026 to review the progress made in Expanding and Deepening of Digital Payment Ecosystem as on 30.06.2026 for the districts in the state of West Bengal. The meeting was participated through VC by Shri Pravin Narayan Bhavsar, DGM, FIDD, RBI; Shri Vikas Tigga, AGM, NABARD; and representatives of major member banks.

At the outset, Shri Balbir Singh, General Manager & Convenor, SLBC West Bengal, welcomed all the participants in the meeting. He briefly narrated about the developments happened in Expanding and Deepening of Digital Payment Ecosystem in all the districts under West Bengal as on 30.06.2026. The major points of discussion along with the action points emerged during the sub-committee meeting are given below:

1. Progress made in Expanding and Deepening of Digital Payment Ecosystem:

Representatives from SLBC West Bengal, stated that 100% digital coverage has been achieved in all the districts for savings as well as current accounts, in any one digital channel, which is commendable.

While stating the overall district wise performance as on 30.06.2026, Representatives from SLBC West Bengal highlighted that, member banks have cumulatively covered 9,84,09,938 number of savings accounts in any one digital channel out of total 9,84,09,938 number of eligible savings accounts, thus achieving 100.00% overall digital coverage in all districts of West Bengal. In case of current accounts member banks have cumulatively covered 20,38,057 number of accounts in any one digital channel out of total 20,38,057 number of eligible cases, thus achieving 100.00% overall digital coverage in all districts of West Bengal.

It was advised to all member banks to keep up the endeavour and maintain 100% digitization achievement.

The meeting ended with vote of thanks to the chair and the participants by Shri Subhabrata Datta, Chief Manager, SLBC.
